**(RENEW TOWN LIABILITY INSURANCE POLICIES)**

**WHEREAS**, the Town's insurance brokers have presented an insurance program to the Town; and

**WHEREAS**, this insurance program renewal includes all of the Town's insurance policies except for the Town's Workers' Compensation policies; and

**WHEREAS**, the proposed program is actually *decreasing* from \$459,991 in 2025/2026 to \$442,762 for 2026/2027; and

**WHEREAS**, the proposed decrease in the program is \$17,229 which is approximately a 3.75% decrease; and

**WHEREAS**, Town staff have recommended that the Town Board bind coverage under the proposed insurance program procured by the Town's broker, Arthur J. Gallagher & Co.;

**NOW, THEREFORE, BE IT RESOLVED** that the Town is authorized to renew its insurance program for an amount not to exceed \$442,762.

**BE IT FURTHER RESOLVED** that the Supervisor, Comptroller, Town Attorney, and Deputy Town Attorney are authorized to execute forms to bind coverage.
